


Regents State Aid Proposal: State Aid to Schools

Recommends a \$2.4 billion total increase in school aid f 201617 school year to invest in the success of our students.



Regents State Aid Proposal: Support Struggling Schools

- f Struggling Schools (\$75 million in 2016): The Regents proposal includes a request for resources for necessinterventions in Struggling Schools.
- f This proposal would provide \$75 million for 120 struggling schools for 3 years, supporting \$600,000 school for:



Regents State Aid Proposal: Professional Development

- Professional Development for Teachers and Principals (\$45 million in 2016-17): We urge you to builton the successive Strengthening Teacher and Leader Effectiveness i (651) being the successive of the successive
- This professional development funding allow for the creation of locallyskilled teams of professional development experts who would provide igorous and standalodsed professional velopment programs, which also reflect an understanding of local teaching needs.
- f The proposal would expand capacity building such as mentoring new teachers, coaching and career ladders.
- f The proposal also includes \$10 million for targeted programming consistent with the goals of the Workgroup to Improve Outcomes and Young Men of Color.



Regents State Aid Proposal: Expanding Family and Community Engageme

- Family and Community Engagement (\$25 million in 20176) \$50 million in 2017-18): Recognizing the critical role families and communities play is supporting schools, the Department is seeking fundouted that illitate and support active, research based Family and Community Engagem strategies
- f The Regents also call for \$25 million over twotaneases for programming consistent with the goals of the Workgroup to Improve Outcomes for Boys and Young Wienhoof
- f Following years of cuts, the Department was forced to close the Oth Nonpublic Schools. With dedicated funding from the Legislature, we reestablish this office to serve nonpublic schools.



Regents State Aid Proposal: Improving Access to Specialized Coursewor

- f College and Career Pathways (\$65 million, reimbursed in 201718):

 After the Regents voted to provide Multiple Pathways, it is time to support and incentivize the creation of high quality CTE programming by:
 - f Increasing the salary cap for CTE instructors in BOCES programs to expand program offerings
 - f Expanding Special Services Aid for non component districts to reimburse actual expense and aid existing grade programs
 - f Funding a new round of P

Professional Development

f In December, the New York Common Core Task Force acknowledged the importance of professional develoas we transition to higher standards.

Recommendation #9 from the task force report:



- f However, the proposed budget provided no additional funding to implement this recommendation, and cut funding to teacher centers.
- f As a member of the Task Force, I urge you to provide million in state funding for professional development



Pathways to Graduation

- f In January 2015, the Regents approved new pathways to graduation including Technical Education (CTE), Science, Technology, Engineering and Math (STEM), Biliteracy, and the Humanities.
- f The new "4+1" option permits students to take four Regents exams and a comparably rigorous pathways assessment to count for the fifth examination required fo
- f To support creation of-highlity multiple pathways programs in school districts Regents recommend a substantial expansion in financial support, including:
 - f Enhanced BOCES Aid for CTE Pathways programs: uctional salaries eligible for BOCES Aid have remained at \$30,000 since 1992. The aidable salaryalftyr BOCES CTE programs should be doubled over the next five years, with 20 percent of the gap funded for sprovided in 20-26017, and 20 percent annually for four years thereafter.
 - f Enhanced Special Services Aid for CTE Pathways programs operated by the Big Five and no component school districts The Board recommends that for 200 76 services be paid at the same levels available for BOCES.



Improve Outcomes for Boys and Young Men 2016



Build Technical Assistance and Support Capaci⁻ 5% setaside on all new programs

Allow for proper oversight, support and technical assistance to distric

The state should enact aesisidevithin all new programs for administrative overs technical assistance.

- f Following the end of the Race to the Top program, and following years of agency funding constraints, the Dep has lost significant capacity to provide districts with implementation support and technical assistance.
- f Since 2011, state budgets have included new educatio programs for which SED has received no additional state support. As districts are faced with implementation or various programs, they rely more and more on the tect support and expertise of the Department.
- It is common in federal programs for the administering 20% for DOH and to be allowed a 5% tasid from grant awards to allow for proper oversight of the program.

proposed budget, the state general fund contribution to the operations of SED account for only 9.5% } (š Z P v Ç budget, compared to 20% for DOH and 58% for OCFS.



Bridge to College and Careers Pilot Program 201617 \$10M Budget Request

Enable Out of School Youth and Adults to Prepare for Postsecondary Stu



- f Bridge programs enable out of school you and adults to obtain critical basic skills, a school equivalency diploma, and industry recognized credentials.
- The Department requests funding to creat bridge program partnerships between addeducation programs and college or training providers in each of the seven Regional A Education Network regions of the state.
- f These programs would include:
 - Career exploration and career assessment;
 - Relationships with employers and colleges; and
 - Apprenticeships and internships.



Higher Education Opportunity Programs 201617 \$9.75M Budget Request

Expand Access to Higher Education for Underrepresented and Disadvanta

Higher Education Opportunity Program (HEOP) \$2.5 M
Science and Technology Entry Program (STEP) \$2.5 M

- The state's higher education opportunity programs are available for students attending public and private colleges throughout the state.
- f These programs currently serve over 30 underrepresented and disadvantaged students.
- f These programs are effective at increas graduation rates and should be expande



Improve the Assessment of Students with Severe 2016-17 \$2.9M Budget Request

Provide smarter assessment options for Students with Di

New funding would support development and implementation of an enhalternate assessment that would allow students with disabilities to modemonstrate their knowledge.

- f For years, the Regents and SED have advocated for relief from federal tes requirements for students with disabilities.
- f Over several years, the Department has been engaged with educators from the state about potential revisions to the NYS Alternate Assessment (NYS program and it has been determined that revisions to the NYSAA are need better assess the range of students with severe disabilities.
- f A Request for Proposals was released in Spring 2015 seeking assessment that address these concerns.
- f With new funding, the Department would seek to move forward with a m appropriate assessment for students with severe disabilities.

Facilities Planning Project Management Sys 2016-17 \$4M Budget Request


Improve Customer Service and Timeliness of Facility Project

State Aid Modeling 2016-17 \$2M Budget Request

Supporting the Executive and Legislature's role in budget-making



- The Department oversees the modeling of over \$23 billion in state aid to public school districts annually, and provides estimate school aid throughout the budget proces. While effective and accurate, the system written in the outdated COBOL system at risk of becoming obsolete.
- f The Department is seeking funding to develop a new system using a modern u interface and enhanced reporting.



Erasure Analysis of Test Results 2016-17 \$500,000 Budget Request

Ensure the integrity of the Assessment Program



- f The Department is seeking funding to conduct erasure analysis of test result better ensure the integrity of the assessment program.
- f Erasure analysis is a commonly used to that involves statistical analysis of students answer sheets to identify irregular patrof changed responses, with a focus on whether there is a statistically unlikely frequency of incorrect answer changes within a sample of students.
